1. <u>Agenda Item no. 10/1</u>: To confirm the minutes of the last meeting of the 9thAcademic Council held on 6th April, 2017.

Agenda Item no. 9/2 In the last meeting it was suggested to change the name of course from "Certificate Course in Gender Crime and Criminal Justice" to "Certificate Course in Gender based violence in women". After discussions it was decided to keep the name as "Certificate Course in Gender Crime and Criminal Justice".

- Agenda Item no. 10/2: To make amendments in the M.Phil./Ph.D. regulations passed by Academic Council held on 15th January 2015 as per the new UGC Guidelines 2016 and 2017 & the directions of Raj Bhawan.
 - Resolution No. AC/10/2: Resolved that the members of the council discussed the M.Phil./Ph.D. Regulation of SPUP, Jodhpur. The following changes suggested: -
 - 1. M.Phil./Ph.D. regulations point no. 2 the composition of Departmental Research Committee (DRC) will be as following:
 - i. Supervisor (Convener)
 - ii. Internal Teacher 2 Nos.
 - iii. External Teacher 1 Nos.

The functions will remain same.

- 2. M.Phil./Ph.D. regulations point no. 6 (C) The course work shall consist of three papers each carrying 100 marks, out of which 60 marks will be for the course work examination and remaining 40 marks for the presentation on relevant areas of thesis Research Work / Ph.D. work.
- 3. M.Phil./Ph.D. regulations point no. 6 (D). The papers shall be on: -
 - (i) Research Methodology and Computer Applications (as per UGC recommendation)
 - (ii) Advance knowledge on the concerned subject.
 - (iii) Awareness of various aspects in which Ph.D. admission is sought by the selected candidate.
- 4. M.Phil./Ph.D. regulations point no. 7, Categories Executive Ph.D. to be renamed as part time Ph.D.
- 5. To write Department Concerned in place of Concerned Department.
- 6. M.Phil./Ph.D. regulations point no. 12(C). The eligibility criteria for recognition as a Research Supervisor for Asst. Professor: Any regular Assistant Professor of SPUP, Jodhpur of the Department concerned having Ph.D. Degree and at least two Research Papers published in refereed Journals shall act as Supervisor in his / her Department.

- 7. Also add in M.Phil./Ph.D. regulations in point no. 12. Adjunct Faculty member as per the guidelines of UGC for "Empanelment of Adjunct faculty in Universities and Colleges" as per shall also be involved in the M.Phil/Ph.D. coursework based on his professional and research proficiency adjudged by the concerned institution.
- 8. M.Phil./Ph.D. regulations point no. 19 (H) Viva-Voce can be conducted online also.
- 3. <u>Supplementary Agenda Item no. 1</u>: To change the nomenclature of 2 years Training Programme in Cyber Security for Mongolian officers to 2 years Diploma in Cyber Security.

Resolution No. AC/10/SA/1: Resolved that the council members approved the same.
