The Vice-Chancellor extended a warm welcome and thanked the members for sparing their valuable time for attending the meeting. He extended a special welcome to Sh Kanhaiya Lal Bairwal, Retd. IPS, Former Member of RPSC and Shri Narayan Lal Gupta, newly appointed Academic Council member who attended the meeting of the Academic Council for the first time.

The Vice-Chancellor thanked the Rajasthan Police for providing infrastructural and other required support for the smooth conduction of the meeting.

**The following items were taken up for consideration:**

1. Agenda Item no. 7/1:

The Vice-Chancellor pointed out that the minutes of the last meeting had been circulated by the office and requested the Members for their comments, if any. As there were no comments, the Vice-Chancellor stated that it might be presumed that the Minutes have been recorded correctly.

**Resolution No. AC/7/1: Resolved that** the Council confirmed the minutes of the 6th meeting of the Academic Council.

2. **Agenda Item no. 7/2:**

Hon'ble Vice-Chancellor presented the minutes of the Board of Studies for the proposed executive program in Security and Conflict Studies to the members and appraise the significance of the proposed executive programme. He describe that this is an innovative and highly specialized programme for working professionals in police department, civil services and others having interest in conflict and security, such as think-tank & academia. He also pointed out that this executive programme will offer an opportunity to serving professionals to obtain a PG Diploma or M. Phil degree depending upon the entry point qualification of the participants. He further informed that this program will be initiated in Jaipur with the infrastructural support of State Intelligence Academy and Rajasthan Police Academy, Jaipur.

**Resolution No. AC/4/9: Resolved that** Council members approved the proposal and forwarded the same to the Board of Management.

3. **Agenda Item no. 7/3 & 7/4:**

After looking to the quantum of the documents Council members appreciated the document (Ordinance and Regulations of the University) that some more time is required to finalize the same. One of the member Dr. Narayan Lal Gupta suggested that to finalize the documents at least two days deliberations is required (one day for Ordinance and one day for Regulations). Further, it was also decided that the members will communicate their suggestion/observations about these documents through mail to the University and the same may be discussed in the University so that in the forthcoming meeting the document may be finalized.

**Resolution No. AC/7/3 & 7/4: Resolved that** the next meeting will be held on 7th and 8th September, 2015 to discuss the Ordinance and Regulations of the University.

5. **Agenda Item no. 7/5:**

Vice-Chancellor discussed about the proposal to start Diploma in Police Studies specifically for those students of UG and PG courses of SPUP who are interested in pursuing a career in policing while continuing with their main stream of degree education in the University. The six months diploma is divided into 6 modules of 18 Credits. The students will pursue this diploma along with their main stream of study. At the end of the course, they will appear in the exam. The members discussed the program in detail and one of the member Dr. Narayan Lal Gupta suggested that teaching/contact hours should be mentioned and the course may be extended for a longer period. Council members agreed with the suggestion given by Dr. Narayan Lal Gupta and it was unanimously decided to restructure the diploma program.





**Resolution No. AC/7/5: Resolved that** the program should be restructured with the suggestive modifications.
