As per the estimate more than 8.2 million stakeholders at different level in country and 1.1 Million stakeholders in Rajasthan required training and support in addressing the child protection issues with efficient and effective manners. To reach to these stakeholders' state and district level highly trained and professional experts will be created by the specialized child protection institute through different kind of short and long terms courses and capacity building programme on regular basis. This nodal institution will be responsible for addressing the technical and capacity building related need of the country and state. At present, the centre is functioning at SPUP Satellite Centre, Rajasthan Police Academy Campus, Nehru Nagar, Jaipur.

#### Purpose of the assignment
