Background

To affirm Rajasthan Government's Commitment towards adopting a rights-based approach to address the continuing and emerging challenges in the situation of children, the Sardar Patel University of Police, Security and Criminal Justice (SPUP), established Centre for Child Protection (CCP) in the year 2015. Purpose of the Internship

The purpose of this internship assignment is to actively support CCP team in effective implementation of Child Protection Programme in Rajasthan. Some of the key deliverables of the Interns are as follows:

- 4. Assist in development of Frequently Asked Questions (FAQs), simplification of child protection laws and social welfare schemes.
- 5. Assist CCP team in running online and offline courses on child protection.
- 6. Assist CCP team in conducting primary and secondary research.
- 7. Assist CCP team in report writing and documentation on child protection.
- 8. Seek active support CCP team in carrying out allocated tasks during internship.
- 9. Any other task assigned by CCP team or decided by Director, CCP-SPUP.

Duration of Internship

Supervisor

Official travel involved: (itinerary and duration)

Travel to villages, blocks, districts in the state, and other venues as and when required up to 4-6 days per month.

Estimated cost of internship

Will be paid monthly honorarium @ Rs.15,000/- per month (including travel within Jaipur and communication). The interns will be expected to work 22 days per month as per specified working hours. In city travel no extra travel allowance will be given. In special case, prior approval will be required. For outside travel allowance will be given as per norms of CCP-SPUP.

Qualification/preferred knowledge/experience

- 1. Fresh graduates or graduates those who have completed their degrees in last three years in a relevant field such as Child Development, Psychology, Sociology, Social Work, Human Rights, Public Administration and Law. Weightage may be given for outstanding academic track record.

- 3. Demonstrated skills in rights-based work, capacity development initiatives including designing and implementing school based/competency-based programmes.
