## **Child Protection Consultant – Data Analyst and Research**

Are you a skilled Child Protection Consultant with experience of delivering high impact evidence-based policy advice in relation to child protection systems strengthening and wider social welfare/ social protection reform processes? Do you have the ability to expand CCP's work and reputation in this area? If so we are seeking a consummate professional to join our Child Protection Research Consultation Services in our Jaipur based office.

The main responsibilities of the Consultant will include but will not be limited to:

- Preparing background papers and concept notes for programs of Centre.
- Contributing to the centre's success by developing research reports and providing technical and management inputs to consulting projects based on strong analytical thinking and up-to-date knowledge and skills.
- Based on major findings, prepare evidence based report describing the situation of children in Rajasthan with special focus on children at the risk/victim of child marriage, child sexual abuse, violence and exploitation.
- Conduct state and national workshop on child protection and inter-state/national convergence with Law-Enforcement officials.

**Successful candidates for this position should clearly demonstrate the following skills and experience:**

- M.S.W, post graduation in statistics/rural development/sociology with at least 3 years of experience in an international organisation/government for the post of Data Analyst and Research. Along with at least 3 academic papers published in peer-reviewed journals of international reputation.
- Demonstrate specialist expertise in data analysis and management and familiarity with statistical and analytical tools.

- Experience of leading and carrying out primary and secondary research utilising a range of qualitative and/or quantitative methods, including research directly involving children and other vulnerable groups.

### **Overall Requirements for Consultants**

- Familiarity with current discourse and good practices in child protection systems strengthening and wider child and social welfare/social development/social protection reform processes, in an international development context.
- Established professional reputation with a range of prominent and active donors/clients working in child protection/social protection (ideally including UNICEF and USAID).
- Ability to communicate effectively in at least one other relevant local language other than English will be an asset although not essential.
